# PBA to Partner With Local Bars on 2006 Identity Theft Public Education Campaign

The PBA is partnering with local bar associations on an important public education campaign about identity theft.

The two-week campaign, “Your Good Name. Protect It. Restore It.,” begins Oct. 24. It is modeled after successful previous statewide education initiatives on wills, real estate, child support, elder law and consumer credit. The campaign is being waged under the direction of the PBA Client and Community Relations Committee and is funded by a grant from the Pennsylvania Bar Insurance Fund and Trust.

Identity theft is the nation’s fastest growing crime. The campaign reminds consumers about simple precautions they should take to prevent identity theft and provides steps they should take if they become victims.

“During the past year, 9.9 million Americans became victims of identity theft, a crime that can ruin credit and result in many hours of frustration for consumers attempting to regain their good standing with banks and other creditors,” said PBA Client and Community Relations Committee Chair Gerri V. Paulisick of Butler.

The campaign kicks off prior to the holiday shopping season to


highlight good habits that shoppers should practice when they are in stores and when they are disclosing financial information that identity thieves crave.

A news conference will be held at a Harrisburg-area shopping mall to announce the campaign. Participating local bar associations are encouraged to hold identity theft prevention events during the two-week campaign period.

Through a partnership with the Pennsylvania Newspaper Association, advertisements will be placed in newspapers throughout the state, and a toll-free hotline will be available for citizens to request a free identity theft prevention brochure.

As of press time, 31 bar associations have committed to be part of the campaign. These include associations in the counties of Adams, Beaver, Berks, Blair, Bucks, Butler, Cambria, Crawford, Cumberland, Dauphin, Erie, Franklin, Fulton, Jefferson, Lancaster, Lawrence, Lebanon, Lehigh, Luzerne, Lycoming, Mercer, Monroe, Montgomery, Northampton, Northumberland, Philadelphia, Schuylkill, Washington, Wayne, Westmoreland and York. ■

## **Allegheny**

### **Disaster Legal Assistance Manual for Volunteer Attorneys**

The Allegheny County Bar Association has completed a Disaster Legal Assistance Manual for Volunteer Attorneys.

After Hurricane Ivan hit Southwestern Pennsylvania in September 2004, Robert Racunas, then president-elect of the ACBA, initiated the idea of the association developing a plan in the event of another disaster.

Almost exactly one year later, Hurricane Katrina struck Louisiana, and many evacuees were expected to arrive in Allegheny County. The ACBA was asked to establish a volunteer pro bono legal assistance plan to assist the evacuees. The culmination of these events led to the development of a Disaster Plan Subcommittee of the Public Service Committee, charged with creating the ACBA's Disaster Legal Assistance Manual for Volunteer Attorneys.

The subcommittee reviewed other bar association disaster manuals and in particular, the Louisiana State Bar Association's Emergency Disaster Training Manual and the Texas State Bar and Houston Bar Associations' resource materials, to be used as prototypes.

This summer, Racunas announced the completion of the ACBA's Disaster Manual. The association is now prepared to launch an emergency pro bono legal assistance program in the event of a disaster.

The manual sets forth the details of the volunteer program and includes critical emergency and legal assistance information. Included is an overview of FEMA and non-FEMA legal assistance, a description of the process of providing legal assistance to disaster victims, answers to frequently asked questions on issues such as housing, property, insurance, unemployment compensation and other relevant issues. There is an extensive referral sources section, as well as a comprehensive appendix with forms, statutes, important telephone numbers and legal services contact numbers.

Katrina taught us that a bar association may incur as much damage as others during a disaster. If the ACBA incurs such damage, the Pennsylvania Bar Association, through its Pro Bono coordinator, David Trevaskis, has agreed to provide back-up assistance, which is vital to a successful plan.

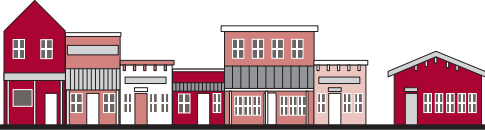
### **Baseball Ticket Distribution**

### Pro Se Divorce Clinic

Bolstered by a grant from the Pennsylvania IOLTA Board, the Franklin County Bar Association launched a pro bono program with a two-fold purpose — helping more low-income clients in domestic relations cases and enabling attorneys without a family law background to assist those clients.

The FCBA's new *pro se* divorce clinic kicked off in September with a one-credit CLE seminar for attorneys to give them the training they need to volunteer for the clinic. Only low-income clients filing for simple, no-asset divorces will be eligible for the clinic. Clients will come through the county's three legal aid agencies, which will refer people who meet income guidelines but are not eligible for their services because of a conflict or other issue.

Volunteer attorneys will provide guidance to clients in completing the necessary forms for filing with the court. Initially the clinic will meet bimonthly, for a few hours in an afternoon or evening, at the FCBA office.

U.S. Chamber of Commerce. Fernando Chang-Muy directs the Philadelphia site of the Funders' Collaborative for Strong Latino Communities and is a professor at the University of Pennsylvania's School of Law and Penn's Graduate School of Social Policy and Practice Work. Imja Choi is the founder and executive director of Korean American Senior Services of Pennsylvania. Anne O'Callaghan is the executive director of the Welcoming Center for New Pennsylvanians and participates in a number of other organizations such as the Alliance for the Mentally Ill, the Visiting Nurses Association of Greater Philadelphia, and the Southwest Community Enrichment Center. The all-star panel of speakers for this event was assembled by the MBA Community Outreach Committee and its partners at the Welcoming Center.

To encourage attendance for this event, the bar association reached out to several area professional associations and chambers of commerce for support. Three chambers of commerce and several professional organizations with combined memberships of over 7,000 prospective attendees shared in marketing the symposium. They did so by publishing articles and ads in their member newsletters, and sending e-mail announcements and personalized invitation letters to members. In exchange for promotional support, the Montgomery Bar Association had included partners' logos and provided promotional consideration in event announcements and press releases.

The symposium set out to address the topic of immigration reform — free of polarizing rhetoric. The panel for the symposium included only those willing to address, in a non-partisan voice, "how immigration and its potential reform will impact each of us personally as well as our schools, churches, businesses and neighborhoods." Speakers agreed to present an unbiased educational explanation

of facts to community members. Elected officials and political candidates were invited to attend; however they were not eligible to present and were urged not to use the symposium as a forum for political gain.

For those unable to attend, the MBA arranged for the event to be filmed and aired locally via public access television. Edited footage will soon be made available to area cable provider Comcast, who in-turn will make the program available via their video on-demand service. The MBA is also exploring alternative delivery vehicles such as montgomerybar.org and podcasts to extend the reach and accessibility of the symposium.

Before, during and after the event — media alerts and announcements issued by the MBA helped to generate awareness of the issue and of "lawyers doing good."

As an added service to lawyers who accept referrals, the bar association will now collect the (slightly increased) referral fee from callers, relieving the attorneys of that effort and related expense. As part of the reworked "Attorney Connection," the structure of what percentage of the total client fee collected by the attorney and returned to the bar association was also changed. ■

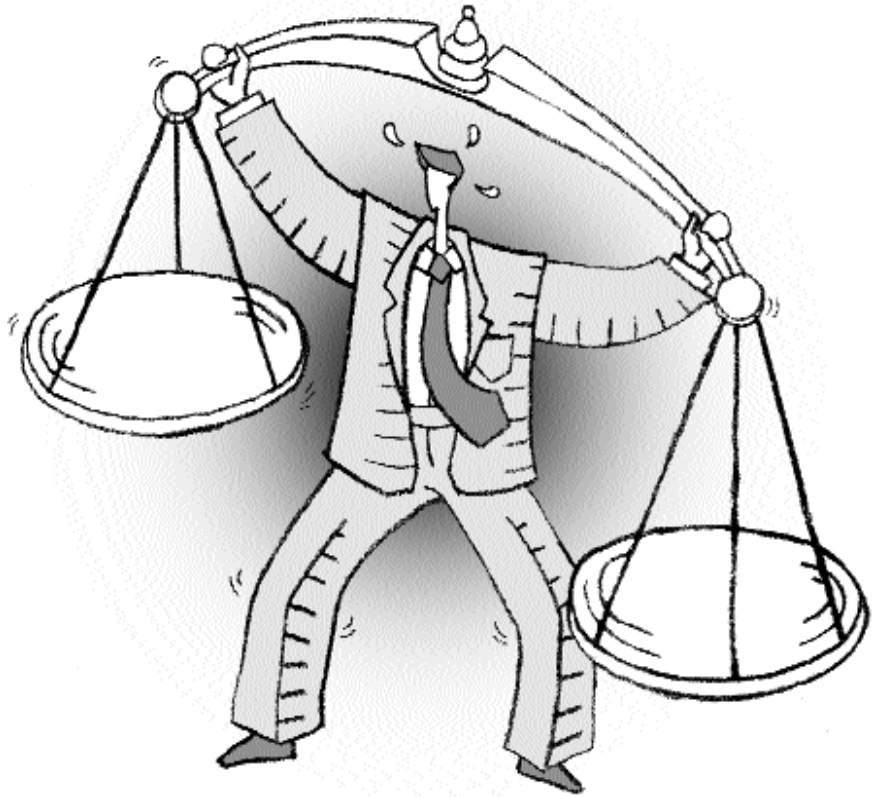
