VOICE Board: The members unanimously voted at the August 8, 2006 meeting to accept Judge Orie Melvin as a member of the Board.

Victim Outreach Intervention Center (VOICE) is a social change agency that works within the community to ensure victim access to justice, autonomy, restoration and safety. It provides free and confidential services to individuals and families who are victims of domestic violence, sexual assault, and other violent crimes.

The board meets on a monthly basis and the duties of the board entail setting policy for the organization, planning, fund-raising, and community relations.

UPMC Passavant Board: Judge Orie Melvin was unanimously elected to the UPMC Passavant Board of Directors on April 29, 2005. Members serve three year terms. Judge Orie Melvin serves as a member of both the Foundation Board which holds regular quarterly meeting and special meetings called by the Chairman. The UPMC Passavant Designated Trustees (PDTs) also meet quarterly.

The purpose for which the Foundation Board is organized and shall be operated are exclusively charitable, scientific or educational.


