If you wish, you may include supporting materials such as a resume, press clippings, photographs, and up to three letters of support.

**ELIGIBILITY:** Any minority Pennsylvania lawyer or judge with at least 15 years of service in the legal profession or service to the minority community.

**PROCEDURES:** The nomination form and supporting materials will not be returned to you. All materials must be on 8½ x 11-inch paper. Use paper clips or binder clips. No staples or binding.

**Nominations must include the following items:**

- A completed application form.
- A letter of recommendation, describing the
- Nominee's activities which, in your opinion, qualify the nominee to receive recognition from the PBA Minority Bar Committee.
- A list of the nominee's affiliations and a list of any awards the nominee has received.
