was first elected to Congress from New York's Ninth Congressional District in Queens in 1978 and served three terms in the House of Representatives. Her work includes spearheading efforts to ensure the passage of the Equal Rights Amendment and sponsoring the Women's Economic Equity Act. In addition, Ms. Ferraro was appointed as the U.S. Ambassador to the United Nations Human Rights Commission by President Clinton in 1994, and held that position through 1996. Currently she is a principal in the government relations practice of Blank Rome, as well as a political analyst for Fox News and a columnist for the New York Times Syndicate.
