Immediately prior to joining the Superior Court, I was a member of the Complex Civil Litigation, Health Law and Commercial Litigation practice groups at Thorp Reed & Armstrong, LLP. I represented clients in federal and state court in addition to representing health care practitioners and health care related entities in corporate matters. My litigation practice included products liability, securities, commercial, professional liability, mass tort and environmental matters. My corporate practice included employment, regulatory and transactional matters. I also practiced within the area of alternative dispute resolution. I was a mediator with JUSTUS ADR (a division of M.A.N.A. Ltd.) and was an arbitrator, mediator and early neutral evaluator with the U.S. District Court for the Western District of Pennsylvania. I was also an arbitrator with the National Association of Securities Dealers (NASD), the American Arbitration Association (AAA), and the National Arbitration Forum. In addition, I have taught an appellate practice course at the University of Pittsburgh School of Law for the past four years.

From 1997 to 2001, I worked on the staff of Judge Maurice B. Cohill, Jr., in the U.S. District Court for the Western District of Pennsylvania. I assisted the court with civil and criminal trials and proceedings, drafted legal opinions and orders, and managed assigned cases. A portion of my practice during this time involved appellate matters since Judge Cohill sat on the Court of Appeals for the Eleventh Circuit on a number of occasions.

As a solo practitioner from 1994 to 1997, I served as counsel to what was originally a five-person oncology group but, through multiple acquisitions and mergers, expanded into one of the largest cancer care providers in Pennsylvania. I was involved in a complex tripartite agreement during this time whereby this group partnered with a publicly traded company and then merged into a non-profit university medical center. From 1992 to 1994, I practiced health law with Nash & Company, P.C., in Pittsburgh. The character of my practice during this time was relatively diverse, consisting of litigation, administrative and corporate matters within the health care area. A significant amount of my time was spent dealing with federal regulatory issues. From 1990 to 1992, I was a general litigation associate with Thorp Reed & Armstrong, LLP.

I am currently a judge on the Superior Court of Pennsylvania, having been elected in November, 2007. Pursuant to 42 Pa. C.S.A. § 742, the Superior Court "shall have exclusive appellate jurisdiction of all appeals from final orders of the courts of common pleas, regardless of the nature of the controversy or the amount involved," except appeals that are within the exclusive jurisdiction of the Supreme Court or the Commonwealth Court. The Superior Court also hears appeals from non-final orders pursuant to Pa.R.A.P. 311 (interlocutory orders appealable as of right), Pa.R.A.P. 313 (collateral orders), and Pa.R.A.P. 312 and 1311 (interlocutory orders appealable by permission). I have not held any other judicial office.

In 2005, I presented at two full day continuing education programs on mediation for attorneys.

During the 1990's, I spoke on several occasions to health care groups on legal issues. During the early 1980's, most of my responsibilities as a masters' prepared nurse revolved around teaching nurses. I also taught students enrolled in collegiate nursing programs during that time and was adjunct faculty at Duquesne University. In addition, I lectured nationally and published in health care journals.
