**In 2009, I was elected to the Superior Court of Pennsylvania for a 10 year term commencing in January of 2010**

**In June of 2016, I was nominated for an appointment on the Supreme Court of Pennsylvania by Governor Wolf. Subsequently, my nomination was unanimously approved by the full Senate and I was sworn in as a Justice on July 27. In order to accept this appointment, it was necessary for me to resign my Commission as a Judge of the Superior Court.**

a) The nature of typical matters which came before you:

**The Superior Court of Pennsylvania where I served most of the last 5 years is an error correcting tribunal which hears direct appeals from trial courts. It was established in 1895, making it about the same age as the Pennsylvania Bar Association. Statistically this Court decides approximately 8000 cases a year, with criminal cases being the most prevalent. Because the workload is so great, the Supreme Court ordered this Court to hear cases in panels of three beginning in 1978. The following year by Constitutional Amendment the size of the Court was increased from its original number of seven commissioned judges to the current level of fifteen.**

**The Superior Court has original jurisdiction over all civil and criminal matters heard in our trial courts across Pennsylvania with two exceptions. Civil cases in which the Commonwealth of Pennsylvania is a party are heard in Commonwealth Court. Criminal cases involving first-degree murder convictions are appealed directly the Supreme Court of Pennsylvania. The Superior Court hears all family court matters, including custody and divorce, civil cases of all varieties and all criminal matters other than first-degree murder convictions. In addition, the Superior Court is the court which decides whether wire taps are justified. During my tenure in the Superior Court, I handled such matters.**

**I must say that although I am excited and honored to be a member of our high court, I thoroughly enjoyed my years as a member of the Superior Court.**

**Seven years ago in answer to that question I asserted my belief that becoming a judge is the highest pinnacle of the legal profession. My experience on the appellate bench has only served to reinforce that conviction. It is the ability to settle disputes fairly and peaceably in a court of law that holds this nation together. Judges play an indispensable role in that process.**

**For me personally, becoming a jurist has been my inspirational goal since the days of my judicial clerkship with the Honorable Robert M Kemp President Judge of Tioga County. To Judge Kemp justice was a most precious commodity to be dispensed with the utmost care insuring fairness to all at every turn. He taught me well. In some ways I feel as though I am a living extension of a wonderful role model.**

**Throughout my time on the Superior Court I took great pride in managing my caseload. I believe that justice delayed can be justice denied. With few exceptions our turnaround time for case was 30 days. We made it our goal to expeditiously resolve each case as it was assigned.**


