

- Keystone Society Member** – A member who has contributed at least \$10,000 in a 10-year period by making annual contributions of at least \$1,000
- Make a single one-time contribution of \$10,000
 - Split your payments into 10 consecutive annual installments of \$1,000
 - Use your credit card to pay in 120 monthly contributions of \$83.34
- Advocates Club Member** - A member who has contributed at least \$7,500 in a 10-year period by making annual contributions of at least \$750
- Make a single one-time contribution of \$7,500
 - Split your payments into 10 consecutive annual installments of \$750
 - Use your credit card to pay in 120 monthly contributions of \$62.50
- Commonwealth Club** – Any member who has contributed at least \$5,000 in a 10-year period by making annual contributions of at least \$500
- Make a single one-time contribution of \$5,000
 - Split your payments into 10 consecutive annual installments of \$500
 - Use your credit card to pay in 120 monthly contributions of \$41.67
- Life Fellow** – A member who has contributed at least \$1,000 in a 4-year period by making annual contributions of at least \$250
- Make a single one-time contribution of \$1,000
 - Split your payments into 4 consecutive annual installments of \$250
 - Use your credit card to pay in 48 monthly contributions of \$20.84
- Associate Life Fellow**– Any senior member of the bar over the age of 40 who contributed at least \$500 by making one lump sum or over a two-year period
- Make a single one-time contribution of \$500
 - Split your payments into two annual installments of \$250
- Young Lawyer Life Fellow** – A member who qualifies as a member of the Young Lawyers Division of the Pennsylvania Bar Association who has contributed at least \$500 in a 4-year period and is making annual contributions of at least \$125
- Make a single one-time contribution of \$500
 - Split your payments into 4 consecutive annual installments of \$125
 - Use your credit card to pay in 48 monthly contributions of \$10.42
- Fellow** – Any member who has not met the requirements for a higher level of recognition but who contributes at least \$250 in the current year.

- Keystone Society Law Firm Member** - A firm that contributes \$10,000 over 10 consecutive years in annual increments of \$1,000

- Commonwealth Club Law Firm Member** - A firm that contributes \$5,000 over 5 consecutive years in annual increments of \$1,000
- Make a single one-time contribution of \$5,000
- Split your payments into 5 consecutive annual installments of \$1,000
- Liberty Club Law Firm Member** - A firm with four or fewer attorneys, that contributes \$1,000 over 5 consecutive years in annual increments of \$200.
- Make a single one-time contribution of \$1,000
- Split your payments into 5 consecutive annual installments of \$200

- 1895 Society Member** - A member of the Pennsylvania Bar Association who has made the affirmative decision to name the *Pennsylvania Bar Foundation* as a beneficiary in an estate planning document such as a will, insurance policy or annuity. No minimum gift is required. 1895 Society Members must complete a Legacy Intention Form, which can be obtained at the Foundation Headquarters.
